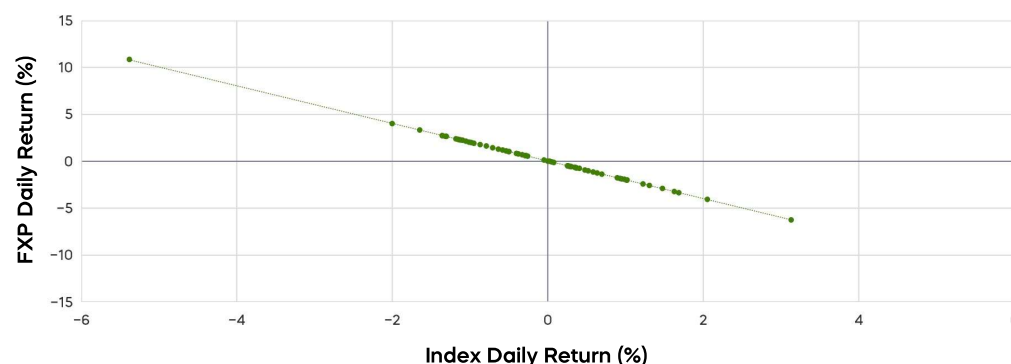

Correlation³ = -1.00

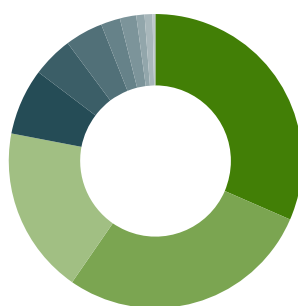
