INDEX DESCRIPTION

The Bloomberg XRP Index is designed to measure the performance of a single XRP traded in USD. The index is constructed and maintained by Bloomberg Index Services Limited.

This ProShares ETF seeks daily investment results that correspond, before fees and expenses, to 2x the daily performance of its underlying benchmark (the “Daily Target”). While the Fund has a daily investment objective, you may hold Fund shares for longer than one day if you believe it is consistent with your goals and risk tolerance. **For any holding period other than a day, your return may be higher or lower than the Daily Target. These differences may be significant.** Smaller index gains/losses and higher index volatility contribute to returns worse than the Daily Target. Larger index gains/losses and lower index volatility contribute to returns better than the Daily Target. The more extreme these factors and the longer your holding period while these factors apply, the more your return will tend to deviate. Investors should consider periodically monitoring their geared fund investments in light of their goals and risk tolerance.

This ETF invests in derivatives (swap agreements, futures contracts and similar instruments) that provide indirect exposure to XRP and does not invest directly in XRP. Investors seeking exposure to XRP directly should consider an investment other than this ETF. XRP is a relatively new asset class and the market for XRP is subject to rapid changes and uncertainty. XRP is subject to unique and substantial risks, such as rapid price swings and lack of liquidity, including as a result of changes in the supply of and demand for XRP, statements by influencers and the media, and other factors. XRP is largely unregulated and may be more susceptible to fraud and manipulation than more regulated investments. Leveraged exposure to XRP will increase volatility.
